After high school, Sister Mary Ann earned a bachelor's degree in English with a minor in music from Viterbo University. She went on to earn a master's degree in English from the Catholic University of America and an educational specialist degree in educational administration with an emphasis on teacher education from Michigan State University. Sister Mary Ann has been a member of the Franciscan Sisters of Perpetual Adoration for 62 years.

Some of her favorite career experiences include serving as the Education Department Chairperson and Director of Teacher Education at Viterbo University for five years, being Superintendent of Schools for the Archdiocese of Omaha, Neb., for five years, teaching a graduate course in Personnel Leadership at the University of San Francisco's Institute for Catholic Educational Leadership for nine summers and teaching English in the Czech Republic for three summers.

A PASSIONATE VOLUNTEER

Although Sister Mary Ann recently retired after serving for 20 years as the archivist for the Franciscan Sisters, her ongoing support of the La Crosse community has led her to service on numerous boards and committees for local non-profits and civic organizations.

"Since its inception, the Foundation has helped Gundersen Health System provide outstanding care through support for medical education and research," she shares. "However, donor support for events (like Steppin' Out in Pink), programs (like Children's Miracle Network Hospitals), and a variety of specific funds (like the Carilee Fund and Paula's Purse) mean an incredible number of lives are touched. Introducing our Vice President of Medical Education

On October 1, 2022, Benjamin Jarman, MD, began serving in his new role as the Edwin L. Overholt, MD, Vice President of Medical Education/Designated Institutional Official (DIO) for Gundersen Medical Foundation.

Dr. Jarman currently serves on the Gundersen Health System Board of Trustees and has been the General Surgery Residency program director since 2010. He has served as acting interim DIO for the Foundation's residency and fellowship programs since the retirement of Dr. Greg Thompson in June 2022.

He has practiced in the Department of Surgery at Gundersen Health System since 2007 and has held various positions on boards and committees throughout the organization, including the Board of Governors, Finance Committee and the Integrated Center for Education Advisory Board. He is also a clinical adjunct professor for the University of Wisconsin School of Medicine.

In his new role, Dr. Jarman will oversee medical education programs at Gundersen, driving the strategic direction for all levels of education, including physicians, residents and fellows, medical students, nursing students and paramedical/allied health students.

Recently, we invited Dr. Jarman to share a bit about himself, his experiences and his goals:

WHERE ARE YOU FROM?

I was born in Marion, Indiana, and grew up in a small town called Upland where my dad was a wrestling coach at Taylor University and my mother was the domestic engineer who made it possible for our family to thrive. We moved to the north suburbs of Chicago when I was 6—then back to Indiana when I was 16 due to my dad's career.

HOW DID YOU BECOME A SURGEON?

As a freshman at Manchester College, I initially planned on becoming an accountant. Then a family friend and mentor, Dr. Bob Jackson, asked me to volunteer on a missionary team in the Dominican Republic. That experience was pivotal, and with the ongoing mentorship of Dr. Jackson, I decided to pursue general surgery as a career.

I graduated from college with a degree in biology-chemistry and then attended medical school at Indiana University School of Medicine.

WHAT BROUGHT YOU TO LA CROSSE?

After medical school, I completed my residency at Mount Carmel Health System in Columbus, Ohio. Then I was hired by Affinity Medical Group in Appleton, Wisconsin, as a general and vascular surgeon. I worked with great partners, but I wanted to teach in an educational setting, and I was lucky to make contact with Gundersen. The Gundersen mission, which focuses on serving our communities through research and education, resonated with me.

I initially applied for a trauma and acute care surgery position, but it did not seem consistent with what I wanted to do long term. About six months later, Dr. Shapiro contacted me, when one of his general surgery partners was retiring. He invited me to visit La Crosse and apply for the new position. I arrived for my interview during Oktoberfest weekend and, sadly, just a few days after Dr. Edwin L. Overholt had died. The mood at Gundersen was deflated, owing to the loss of such a tremendous individual. It is serendipitous that I now serve in the role named after him.

TELL US ABOUT YOUR FAMILY?

Annette and I met just outside the college cafeteria during our junior year at Manchester. She has always amazed me with regard to her intense spirituality, selfless dedication to others, commitment to raising our children and her humor. We recently

celebrated 24 years of marriage, and I am so thankful for her impact on my life. We have three amazing children: Nicholas (19), Gabby (16) and Oliver (13).

WHAT DO YOU LOVE ABOUT LA CROSSE?

Minutes after arriving for my first visit to La Crosse, Dr. Steve Whitford (Opthalmology) took me for a bike ride up Bliss Road to the Alpine Inn for a Spotted Cow. I was pretty much sold at that point. What a great introduction to this beautiful area! My wife and I believe that outdoor activities support good health and can be an outlet that builds resilience, so we saw La Crosse as a great place to raise our children. We love the area's unique mixture of city life and rural living.

Since then, we have grown to appreciate many things about the community, and the most impactful is our church. We were blessed to start attending First Free in Onalaska and have been engaged with the church since 2009. Our faith is vitally important to us.

WHAT DO YOU LOVE ABOUT GUNDERSEN?

I was initially drawn to Gundersen by the mission, and it didn't take me too

long to know I'd found the right place. I appreciate the leadership style at Gundersen. Physicians have input into decision making, which is empowering. There are opportunities to put forth ideas and get support for initiatives that support our mission. Many healthcare organizations make decisions based primarily on cost rather than on what is best for patients—but Gundersen puts patients first, and that has a ripple effect to sustain my resiliency as a physician.

I also love that Gundersen has established roots in education dating back to its early development. Our clinical learning environment is special owing to so much dedication over the past century in establishing expectations and setting the tone for medical education to thrive.

HOW DID YOU CONNECT WITH GUNDERSEN MEDICAL FOUNDATION?

In 2008, Dr. Tom Cogbill announced that he was going to step away from his role as surgery residency program director. I remember calling him and expressing an interest; he was supportive. Tom has been and continues to be a terrific mentor to me. I became the associate program director in 2009 and then the program director in 2010.

HOW DO YOU CONNECT YOUR PREVIOUS EXPERIENCES TO YOUR NEW ROLE?

Dr. Greg Thompson was a great mentor to me. He has helped me see the bigger picture of undergraduate, graduate and continuing medical education and has always supported me in my initiatives. Through his support, I gained regional and national opportunities and expanded my understanding and experience with leading educational initiatives. Being a program director also provided incredible experiences with human resource challenges, having tough conversations, establishing new educational initiatives, implementing innovative programs and providing routine assessments of both learners and faculty.

WHAT EXCITES YOU MOST ABOUT YOUR NEW ROLE?

I'm excited and inspired by the opportunity to serve in this new role. The work is so impactful. I love working with residents and students and look forward to the opportunity to coach program leaders where I am able. I will use my past leadership experiences, as well as the lessons I have learned from mentors, to help others overcome challenges.

WHAT DOES YOUR PERFECT DAY AWAY FROM WORK LOOK LIKE?

I love life and am satisfied with many different activities. One version of a perfect day would include a bike ride (maybe with my whole family), a church service and a family dinner. If I was able to fit in a nap, some manual labor and some reading, it would be just about perfect.

WHAT IS YOUR FAVORITE QUOTE?

The first quote that comes to mind was highlighted in the the movie *The Gladiator*. Maximus Aurelius states, "Things we do in life echo in eternity."

Also, one of many verses from the Bible that really speaks to me is Hebrews 12:1. It reads, "Therefore, since we are surrounded by such a great cloud of witnesses, let us throw off everything that hinders and the sin that so easily entangles. And let us run with perseverance the race marked out for us."

The power of philanthropy

Making a difference in the lives of others is always impactful—but when passion is united with purpose, giving becomes transformational. Such is the case for Ron and Jane Rada, longtime supporters of Gundersen Medical Foundation, who recently made a significant gift in support of medical research and education.

In 2018, Ron and Jane provided funding to support a collaborative research initiative between Gundersen Health System and the La Crosse Institute for Movement Science (LIMS) that was created in 2005 at the University of Wisconsin-La Crosse (UWL). The project brings together scientists and clinicians from each institution to study the biomechanical factors related to common injuries in runners and other athletes to better understand how they occur and what interventions could be made to prevent or better treat these injuries.

The gift was transformational on several levels. Not only did it allow Ron and Jane to draw on their passions for education, collaboration, and fitness, but the project is already changing lives. "Ron and Jane's investment in medical research and education illustrates the power of philanthropy," says the Foundation's Director of Philanthropy Mandy Richardson, CFRE. "When we invest in these programs and draw on collaborative opportunities, we improve the overall health of our community and enhance the quality of care for patients at Gundersen Health System."

TEACHING AND LEARNING

Ron and Jane are passionate about education because of the role it has played in both their personal and professional lives. Ron and Jane grew up 10 miles from

each other in rural South Dakota. Both came from families with limited economic means who recognized education as one pathway to a successful future.

After earning undergraduate degrees from the University of South Dakota-Springfield, they got married and continued their education. Ron earned a master's degree from the University of South Dakota-Vermillion and a doctorate degree from Montana State University, while Jane earned a master's degree from Montana State University and, later, an MBA from UWL.

In 1975, they moved to La Crosse for their careers. Ron joined UWL as a professor of Biology and Microbiology and also served as co-director of the River Studies Center. After 22 years, he moved into administrative roles, including Associate Dean of the College of Science and Health, Director of Graduate Studies, and Interim Provost. Ron retired from UWL in 2007 but continues to volunteer at the university.

Jane also had an expansive career in education, spending 25 years as an instructor in the Business Division at Western Technical College and later coordinating the college's accreditation process before retiring in 2003. She began volunteering at Gundersen in 2004, while also serving as a board member for several local non-profit organizations.

Ron and Jane feel fortunate to now be in the position to give back, both through volunteering and philanthropy. They look for opportunities to support organizations that positively impact the community and that speak to their passions, including education.

"We believe in Gundersen and in the Foundation," explains Ron. "The focus on education speaks to us—and we have the same attitude towards UWL. These are exceptional organizations."

FOSTERING COLLABORATION

In addition to focusing on education, Ron and Jane chose this initiative because it featured another aspect that is important to them: community collaboration. "We wanted to make an investment in a collaborative partnership that would build on the unique strengths of each institution to better serve the Gundersen clinical staff, UWL faculty and students, Gundersen Residents and the La Crosse community as a whole," says Jane. "Our philanthropic goal is for each gift to always be about more than what we are bringing to the table."

According to Dr. C. Nathan Vannatta, a physical therapist in Gundersen's Sports Physical Therapy Department, the collaboration between Gundersen and the LIMS lab has been beneficial. "Not only has the project impacted clinical practice by informing standards of patient care and creating meaningful and formative experiences for healthcare professionals and students," he explains, "but the collaboration enables everyone to learn how scientific knowledge in movement science is acquired and then integrated in a meaningful way within the practice of healthcare. It has been a win-win for both of our institutions."

As a practicing physical therapist, Dr. Vannatta is also an instructor with Gundersen's Sports Physical Therapy Residency Program and part of the LIMS research group working on this initiative. He and Dr. Tom Kernozek, the LIMS director, are able to see first-hand the impact hands-on research has on learners.

"This interaction between students and residents has been really meaningful, especially when I see one of those lightbulb moments as they are able to connect the dots between something we have learned in the lab and how it affects what they do with a patient," shares Dr. Vannatta. "As we move forward, we are hoping to offer opportunities for community members to be able to access the lab facilities and directly benefit from our research by learning about their individual movement patterns and how that may influence their injury risk."

PROVIDING THE SPARK

When it comes to philanthropy, Ron and Jane see themselves as catalysts—as

people who plant a seed for a project or initiative that is connected to something they care about. Their hope is that the seed sprouts and the idea resonates with others, thus taking an idea even further to build capacity.

In this case, it's clear that goal has been met. While the project is ongoing, their gift has already had a positive impact. "We have had the opportunity to assist local high school athletes in screening for injury risk and collegiate athletes hoping to characterize factors that may contribute to running-related injury—all while providing undergraduate, graduate and resident learners state-of-the-art research opportunities that influence clinical practice and the delivery of healthcare right here in La Crosse," says Dr. Vannatta. "Ron and Jane's gift truly benefits the community at large and serves as an investment in the next generation of healthcare professionals." +

From learner to leader

Today, C. Nathan Vannatta, PT, DPT, SCS, is a physical therapist in Gundersen's Sports Physical Therapy Department—but in 2014, he was a graduate student in UWL's physical therapy department. There, he was part of a research practicum led by Dr. Kernozek, director of LIMS, and contributed to a project examining knee biomechanics during sports-related activities and the connection to ACL injury risk (as well as other studies investigating running mechanics and their relation to injury). Later in 2014, Dr. Vannatta enrolled in the Gundersen Sports Physical Therapy Residency Program where he had more experiences with LIMS. Then, in 2015, he joined the clinical staff at Gundersen. Recently Dr. Vannatta was appointed Associate Program Director of the Sports Physical Therapy Residency Program at Gundersen, which means he is not only participating in the research efforts at LIMS but also helping to lead the education efforts.

"One of the most precious commodities in the present, fast-paced day and age is our time. Thanks to the generous



philanthropic support by the Radas, I have protected time to help develop research protocols, offer services and analyze data that otherwise would have to be fit into my full clinical schedule," explains Dr. Vannatta. "My hope is that these continued efforts will lead to LIMS being a valuable and accessible resource for our community members." +

An investment in compassion

As a boy growing up in La Crosse, Tim Padesky felt lucky to live in a neighborhood with several retirees who enjoyed hiring out their snow shoveling and lawn mowing chores. These odd jobs provided Tim with valuable learning opportunities, not to mention some "walking around" money. By the time he was 13, he even had some savings.

Tim's savings came in handy when his dad, Don, a World War II veteran, encouraged him to buy two shares of NSP stock that had come available for \$67 each. Those shares and their earnings remained untouched for 54 years—until Tim decided to partner with Gundersen Medical Foundation on a special initiative. Influenced by Tim's health challenges and a desire to help others, he and his family decided to use the earnings to establish The Tim Padesky Family Transplant Endowment Fund.

HOMETOWN PRIDE

Tim has always been proud to live and work in his hometown. After graduating

from Central High School in 1972, Tim worked for his dad, a contractor, as a residential electrician. In 1977, he completed an apprenticeship at Western Technical College and became a journeyman electrician.

For the next few years, he was employed by Johnson Controls where he worked on

large industrial and commercial projects. These projects required him to travel often, sometimes for weeks at a time. Eventually, the travel became tiresome, and Tim decided to start his own business. In 1982, Tim founded T.D. Padesky Electric.

In 1996, Tim married Tara Johnson, and the couple started a family. Nicholas was born in 1997, and Layna was born in 1999. Because the kids grew up playing baseball and softball, Tim became active in the Shelby Youth Ball organization, including serving as its president. Nicholas and Layna went on to graduate from Central High School just like their dad. Today, Tim continues to serve his community as a Shelby Town Supervisor.

"I am proud to own a business in the town where I was born and raised," shares Tim. "We've been blessed with great employees and customers; we've made so many community connections."

In the fall of 2022, T.D. Padesky Electric celebrated its 40th anniversary. Tim takes pride in having worked with local businesses like Kwik Trip, Walzcraft, Ray Hudson Chevrolet—and many more—on their commercial and industrial projects. He is also fulfilled by knowing that his own small business has positively impacted his hometown's economy. Not only has T.D. Padesky Electric supported his own family, it has also supported the families of his many employees, some of whom have been with the company for decades.

GRATITUDE FOR CARE

In 2013, Tim began to suffer physically. Later that year, he was diagnosed with kidney failure. Tim's sister, Mickey, was a match, and she became a willing donor. In 2014, Tim underwent a kidney transplant at UW-Health in Madison. However, Tim was grateful to be able to receive most of his care at Gundersen Health System, the same provider he had used for his whole life.

"The quality of care I have received at Gundersen—right here in my own hometown—is priceless," shares Tim. "I have always felt comfortable and confident in my care. I know not everyone is so lucky."

Although the transplant was successful, Tim has had to manage other healthcare challenges. In 2017, he was diagnosed with multiple myeloma (blood cancer) and had to undergo a stem cell transplant (using stem cells harvested from his own body). In late 2021, he suffered an infection that required additional treatment.

It was around this time that Tim and Tara began to reflect on the worry and stress that transplant patients and their families experience. They felt fortunate to have been able to manage the expenses

associated with multiple trips to Madison, including gas, food and lodging, yet they knew many families were not in the same position.

Now, thanks to Tim's business savvy and the value of compounding interest, families who are dealing with an organ transplant may receive emergency financial assistance for gas cards, hotel accommodations, food vouchers or other needs through The Tim Padesky Family Transplant Endowment Fund.

"When a loved one is facing a healthcare crisis, just worrying about their care and well-being is stressful enough," says Tara. "We realized how much more difficult it would be to also have to worry about unexpected costs—and we wanted to help."

CHARITABLE BEQUEST Consider naming Gundersen Medical Foundation as the beneficiary of your income in respect of decedent (IRD) assets while leaving your cash and other investment assets to your heirs. Why? Charities are tax exempt and, unlike your heirs, will not pay taxes on IRAs and other retirement plans. Complete a beneficiary designation by contacting your plan administrator.

CHARITABLE REMAINDER TRUST Funding a charitable remainder trust with your IRA or other assets as part of your estate plan can help you provide for heirs and reduce their tax burden. The trust will pay heirs income over a number of years. Heirs will pay tax on the income over time, as opposed to facing a large tax bill if IRA proceeds were given in a lump sum. At the end of the trust, any remaining principal will go to help further our mission.

CHARITABLE GIFT ANNUITY Some individuals prefer leaving their IRD assets to fund a charitable gift annuity that will benefit a beneficiary with lifetime fixed payments. A gift annuity is easy to establish with our organization. With this plan, usually only one charity is the named beneficiary of the remaining value.

IRA CHARITABLE ROLLOVER If you are 70½ or older, you can make a gift of up to \$100,000 from your IRA every year. Making direct charitable gifts from your IRA is one of the best ways to give. Gifts from your IRA are not included in your adjustable gross income.

Compassion for kids: One family's fundraiser for CMN Hospitals®

Anyone who has spent time with Jim Busta has likely heard him say, "It's a good day to be alive." Jim, a retired educator and the ongoing leader of The Jim Busta Band, has used this motto for decades to spread positivity and gratitude. Recently though, the sentiment took on an even deeper meaning.

In February 2022, Jim was diagnosed with pancreatic cancer, and by early March, he was undergoing chemotherapy treatments at Gundersen Health System. Despite the difficult diagnosis, the support of his family and access to high-quality, compassionate care left Jim feeling blessed. As his treatments continued, though, Jim was heartbroken to see young patients and their families also dealing with cancer. Together with his wife, Mary Lou, and their children, the Busta family connected with Gundersen Medical Foundation to learn how they could make a positive impact. During that meeting, the Bustas learned about Children's Miracle Network Hospitals, a program that provides assistance to families with children facing medical challenges, including cancer and they were all inspired.

Their plan was to invite family members and friends to make a \$20 donation in Jim's honor to CMN Hospitals. In appreciation for the gift, each donor would receive a t-shirt featuring Jim's wellknown motto.

Initially, the family ordered 450 t-shirts and set their fundraising goal at \$5,000. To their astonishment, that goal was achieved in just 24 hours—and the donations continued to pour in. Another 400 t-shirts were ordered, and in the end, over \$46,700 was raised to support CMN Hospitals.

"To say that we are overwhelmed is an understatement," shares Jim. "It feels good to be part of making a positive impact. This experience shows that good things can come from difficult situations."

HONORING IMPACT

Considering the number of lives Jim and Mary Lou have touched as educators and musicians, it is easy to see why the fundraiser was so successful.

Jim spent years as an English teacher and coach in northeast Iowa before becoming a principal. In 1985, he became a superintendent in Spring Grove, Minn., where he worked for 25 years before retiring in 2010. Mary Lou taught Family and Consumer Science before working for 23 years in the Spring Grove and Caledonia, Minn., school districts as the director of the Early Childhood & Family Education Programs. She retired in 2011.

Outside of education, the Bustas are well-known for their passion for polka. Jim started playing the button accordion as a boy and transitioned to the concertina. He and Mary Lou have always enjoyed polka music, and their children grew up attending live performances and music festivals.

In 1979, Jim started The Jim Busta Band, a popular group that has performed throughout the U.S. and in Europe. Growing up, their son, Chad, and daughter, Mollie, played in the band. Eventually, Mollie would go on to have her own successful music career. Using the stage name "Mollie B," she has performed with a variety of musical groups including Squeezebox. In 2011, she was also named host and coproducer of "The Mollie B Polka Party," which airs weekly on RFD-TV.

While the fundraiser was doing well initially, once Mollie B shared the details with her fans, the response was outstanding. Many of her fans know the family's musical background, and some have even seen her perform with her father. To date, donations have come from 33 states, with a good number coming from the Bustas' musicloving fans.

"We are so honored by the outpouring of compassion and generosity," says Jim. "Our hope is that the funds raised will help many young people and their families know that people care and are willing to provide a little extra support during tough times."

Giving back and paying it forward

Steven and Lynnetta Kopp were raised to care about community and to value giving—especially "giving back." That is why they are proud supporters of Gundersen Medical Foundation. Not only do they see the impact of the Foundation in our community, but as they love to share, they are first and foremost grateful patients.

Steven grew up on a farm in Centerville, Wis., and has considered Gundersen Health System his healthcare provider for over 60 years. His family doctored at Gundersen, and when he and Lynnetta moved to the area from Minnesota to be close to family, there was no question that Lynnetta would obtain her healthcare at Gundersen as well.

When Steven's mom began to decline in health, the family witnessed first-hand the compassionate care for which Gundersen is known. "The outlook for Steven's mom was poor, but Dr. Greg Thompson did not give up. He gave her seven more years of life, which meant seven more years of family," remembers Lynnetta. "Her Gundersen team cared for her—and about her—until her very last breath."

Before the Kopps moved back to the La Crosse area, their careers placed them in a variety of cities, including Minneapolis, Los Angeles and Chicago. "We've lived in a lot of cities with many different medical facilities," says Steven, "but the care we have received at Gundersen is second-to-none. People who leave the area soon see the difference, which is why we chose to return to Gundersen for our healthcare even when we didn't live nearby."

For Steven and Lynnetta, supporting the Foundation is a way to "give back" for the care they receive while also "paying it forward" to ensure the same quality of healthcare for future generations.

In addition to their personal experiences, the Kopps' professional experiences have also given them confidence in their choice to invest in the Foundation. Steven worked in the financial industry as the chief information officer of a large accounting firm before retiring six years ago. A dedicated community volunteer, Steven has served on the La Crosse School Board and the board for The Parenting Place. He currently volunteers for WAFER and serves on the board of directors for a regional bank, as well as on the Advisory Board for Western Technical College's IT Program.

This community involvement has allowed him to meet other volunteers, including many Gundersen leaders and employees. "I see many people who are part of Gundersen's care teams are also part of our community team," says Steven, "and that impresses me."

Lynnetta's career expertise in fundraising and non-profits led her to serve in a variety of leadership roles in the community, including positions at the University of Wisconsin-La Crosse, the Humane Society of La Crosse and Coulee Region RSVP, Inc., where she served as the Executive Director for 15 years. By the time she retired five years ago, she had witnessed the many ways Gundersen partners with other community organizations, and she had begun to learn more about the breadth and depth of the Foundation's programming.

"All gifts to the Foundation permeate throughout the community," she says. "Whether it's support for medical education, research, or initiatives that improve population health, the Foundation is actively working to increase the quality of life for everyone."

Because the organization's mission aligns closely with her own, Lynnetta joined the Foundation's Board of Directors in 2015. She serves on the Philanthropy and Nomination Committees and is currently the vice chair.

IMPACTING THE NEXT GENERATION

In retirement, Steven and Lynnetta continue to volunteer and to enjoy their hobbies. While they both enjoy traveling and dogsitting their two "granddogs," Steven enjoys motorcycling and Lynnetta enjoys running marathons.

Several years ago, the couple also became members of the Foundation's Legacy Society. "It was easy to include the Foundation in our estate plan," say both Steven and Lynnetta, "It feels good to give, knowing the Foundation will be an excellent steward of our gifts." +
