The training is mandatory for supervisors of employees who have a Commercial Driver's License (CDL) and are subject to the Federal Motor Carrier Safety Administration (FMCSA) drug and alcohol testing guidelines. This requirement also applies to other DOT agencies subject to federal testing regulations including Transit, Maritime, Railroad, Aviation and Pipeline.
